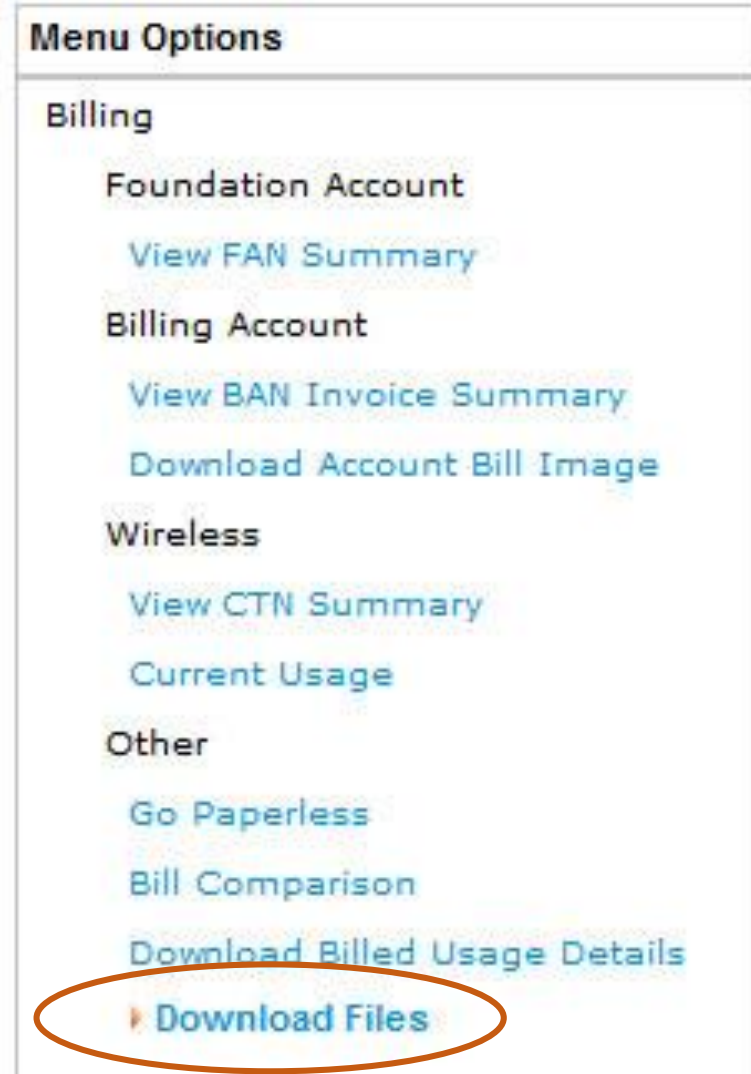

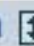

*Note
